This committee is already making proposals to be adopted at our Boston Congress, concerning governance by your Bureau and about our Committees:

- the existing ones: Program Committee and Nominating Committee
- the new ones: Communications (Q 197) and Membership (Q 201).

2/ Mrs. Esme Du Plessis is chairing the Communications Committee (Q 197).

She is currently considering:

- publishing a newsletter in electronic form, as an interactive communication tool, to be sent more frequently to inform AIPPI groups
- having a paper Journal, to publish high quality articles about substantial issues.

The efforts of AIPPI (suite)

3/ The Membership Committee (Q 201) is chaired by Luis Alfonso Duran, our former Reporter General and Member of Honor.

In order to increase our membership up to 12,000 at the Paris Congress in 2010,
AIPPI needs the help of each group and every member,
who should provide their advice
as to how they can attract more IP specialists in their country.

4/ One more practical detail: the <u>master calendar</u> is now available on the AIPPI website.

It is very useful to follow all the IP meetings that might be of interest to everyone.

AIPPI relations

1/ In the past:

a) Your Vice president went to Moscow two weeks ago, to participate in the 50th anniversary of the Russian group of AIPPI.

There again, problems and solutions were exchanged between professionals from Asian and European countries.

b) Our Reporter General, Jochen Bühling, went to Vilnius for the Baltic IP conference last September.

You will find his report in the last Newsletter 25.

2/ In the future:

a) Next April, in Mexico City, AIPPI will participate in a four-day seminar with ASIPI and IPO.

This important seminar will deal with the impact of free trade agreements on IP rights in the Americas. Many topics will be discussed there, even on the transfer and commercialization of technology.

You can read the preview of this seminar in an article written by Guillermo CAREY published in the last Newsletter 25.

b) As you know, it is contemplated to have a treaty on the <u>IP privilege</u>, and specifically on the client privilege covering opinions given by IP advisers.

The client should not be required to disclose IP opinions to anyone, particularly not to a judge, even when such opinions have been communicated outside their country of origin.

On this issue, a new committee (new task force Q199) is chaired by another Member of Honor, Michael Dowling. You can read his article in our last Newsletter 25.

In May 2008, AIPPI will also join WIPO in Geneva in the task it has undertaken on the question of this privilege to be granted to IP professionals and on the contemplated treaty, which is necessary in order to achieve a uniform basic system, for foreign professionals an other country in the world.

Conclusion

Once again the issues and perspectives that we have just heard, show that all of us have much to do.

As a member of the AIPPI Bureau, I am prepared to set myself to this work.

Our association is a perfect tool and forum to reach a reasonable international solution taking into account the necessary equilibrium within the general interest.
